Deborah Glazer, Ph.D. is faculty, Child and Adolescent Psychotherapy Training Program at William Alanson White Institute and The Institute for Contemporary Psychotherapy, and is a supervisor and faculty member at The Psychoanalytic Psychotherapy Study Center. Dr. Glazer is a psychologist/psychoanalyst in private practice in the Chelsea section of NYC. She has numerous publications and presentations on working with LGBTQ families and is co-editor of *Gay & Lesbian Parenting* (Haworth Press, 2001).

Jessica Rothberg, Esq. has been in private practice as a family and divorce mediator for nearly 15 years.
